Enforcement updates



Romanian Data Watchdog fines banks

The National Supervisory Authority for Personal Data Processing (ANSPDCP) recently issued fines on banks for violating the General Data Protection Regulation.

Banca Transilvania SA was fined with RON 487,380 for breach of confidentiality and security of personal data and ING Bank NV was fined with RON 14,620 for processing the personal data of individual after the conclusion of the contractual relationship.



Double trouble for TikTok

In UK, High Court of Justice has issued judgment against TikTok, by allowing a 12-year-old girl to anonymously sue TikTok and its parent ByteDance for violating data privacy rights. The Italian data protection authority, Garante has also announced that it will investigate TikTok's data protection practices. Its move is aimed at securing data privacy of Italian minors.

FTC settles with travel company

SkyMed International, Inc., a travel services provider entered into settlement with the US Federal Trade Commission (FTC), after investigations revealed that it had failed to secure sensitive personal information of consumers. As part of the settlement, SkyMed will adopt a comprehensive information security programme, get its data security program assessed by FTC approved independent organisation and produce certification for its data protection compliance by its senior executive annually.



CafePress Inc. enters into multistate settlement for data breach

Coalition of AGs from New York, Connecticut, Indiana, Kentucky, New Jersey, and Oregon, have entered into a settlement with CafePress Inc. The settlement follows an investigation of a data breach owing to which personal data of 22 million consumers was compromised. As part of the settlement CaféPress Inc. agreed to adopt stringent data security measures and pay settlement amount of USD 2 million.

- **Board of Governors of the Federal Reserve System, Federal Deposit Insurance Corporation and Office of the Comptroller of the Currency jointly propose requirement of notification within 36 hours of computer-security incident.**



- **Personal Information Protection Commission, Japan proposes draft rules to revise data breach reporting of specific personal information.**



- **New York Assembly passed a law suspending the use of facial recognition and other biometric identifying technology in schools until July 1, 2022.**

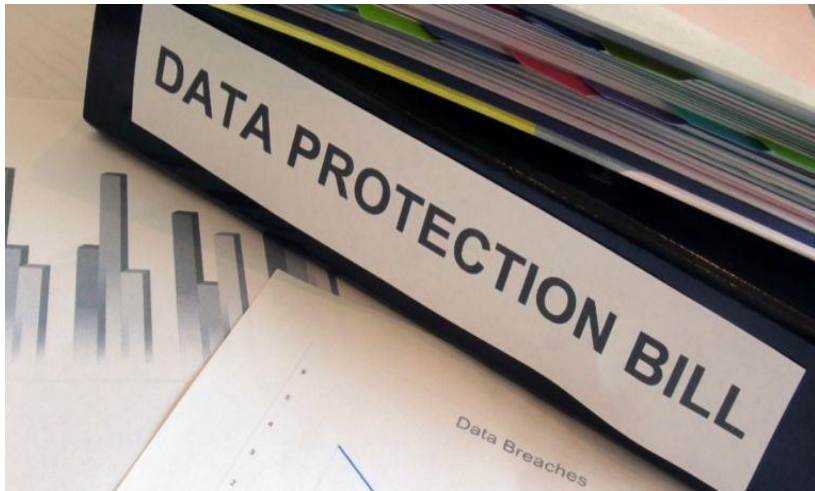
